Description of Change to Contract:

Additional work to complete the Ashmont & Lottie Lake Water Treatment Plants upgrades and transmission main extension up to Ashmont Water Treatment Plant. To include the process piping and equipment work inside both the Ashmont and Lottie Lake water treatment plants as per the attached drawings, specifications and Beretta Pipeline quote.

Payment for each item shall include the following;

- Supply of all labour, material, equipments, and plant for the installation
- Coring work inside Ashmont and Lottie Lake plants required to complete the work as outlined in the attached specifications
- Cathodic protection for all metallic pipes and fittings
- Flushing, pressure testing and disinfection
- Commissioning and start up
- Submission of record drawings and O&M manuals
- Coordination with the Electrical contractor and the County
- Site work restoration

All incidental work and items required to complete the work for which payment is not specified elsewhere.
