Cancelled portions to be consolidated with respective titles.

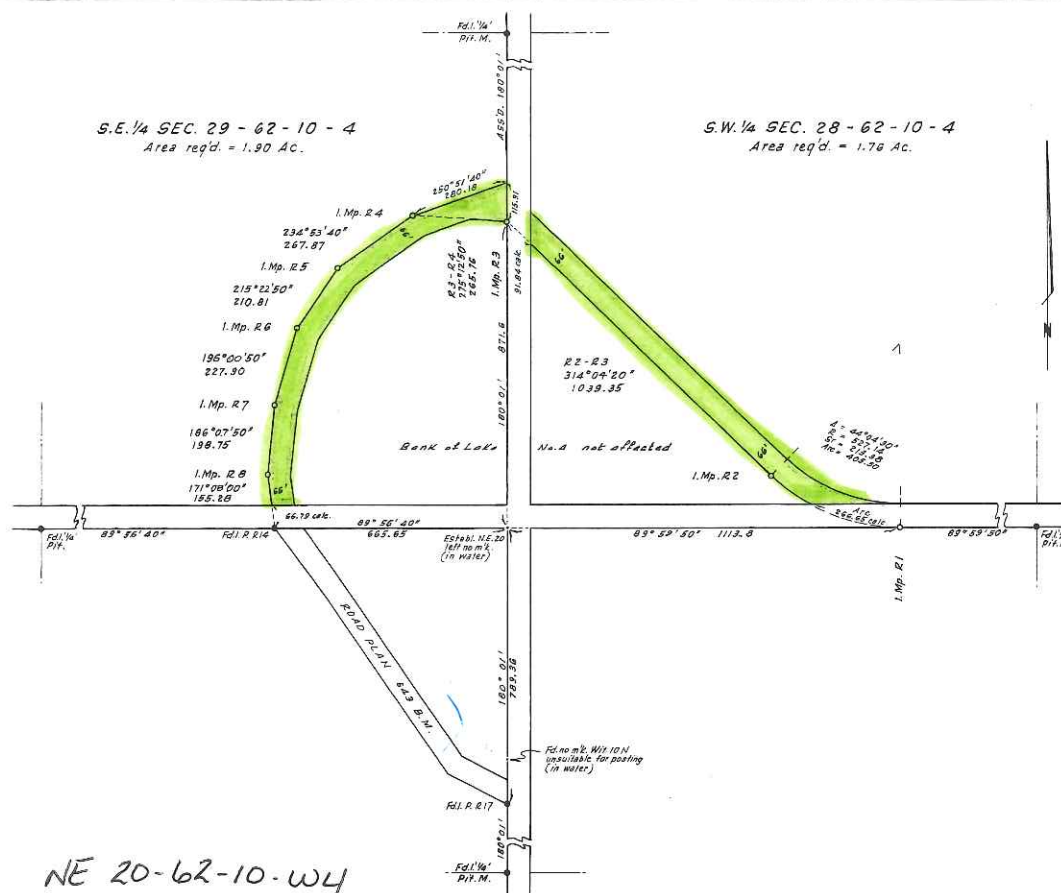

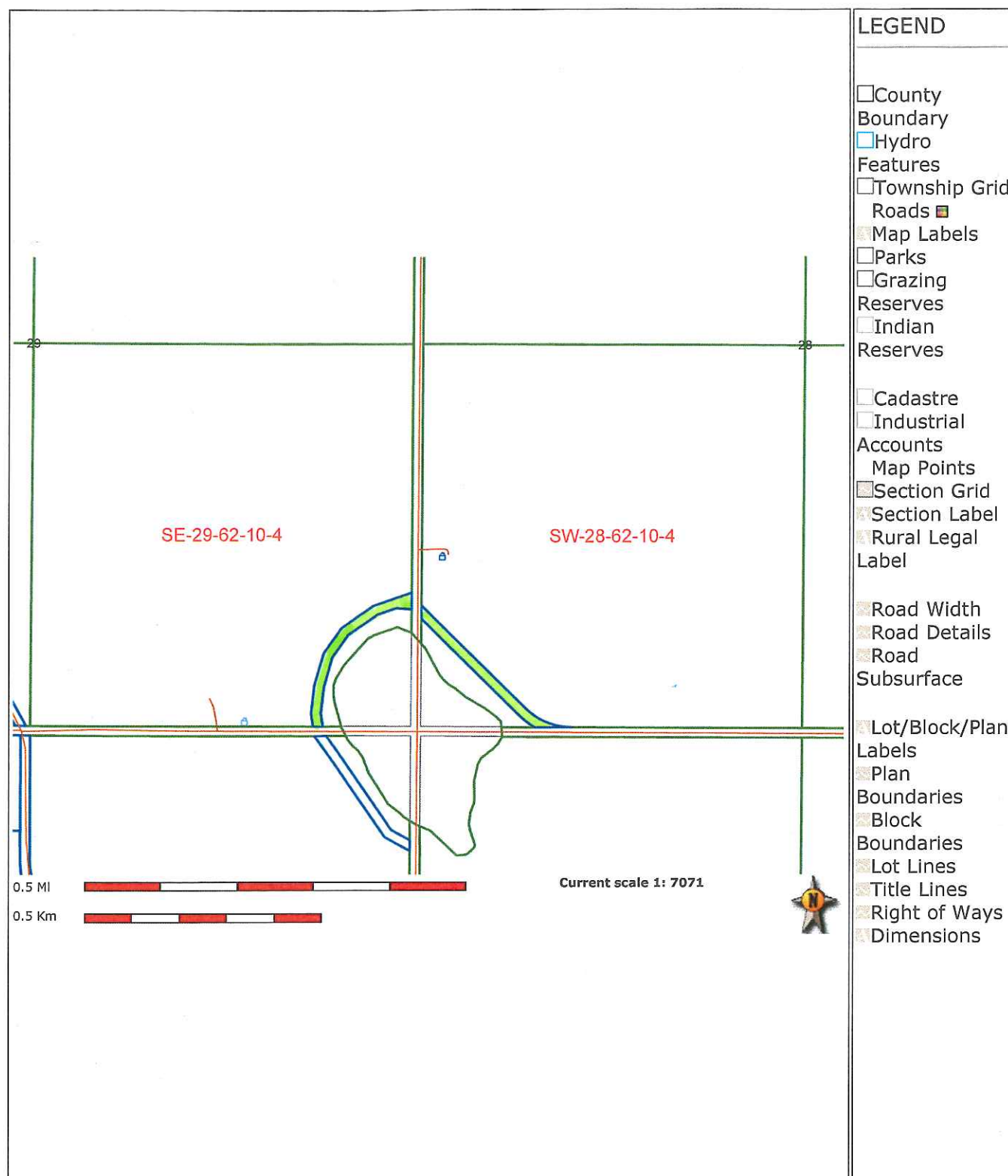
